BRIEF HISTORY AND OBJECTIVES OF JUDICIAL ACADEMY, JHARKHAND

The Judicial Academy, Jharkhand was established on 04/01/2002 at Ranchi, under the patronage of Hon'ble Mr. Justice V.K. Gupta, the first Chief Justice of Jharkhand High Court pursuant to the directions of the Hon'ble Supreme Court of India passed in "All India Judges Case" reported in 2002 (4) SCC 247. Academy was initially situated in the part building of Shri Krishna Institute of Public Administration (SKIPA) at Meur's Road, Ranchi and hostel facilities were also being provided by SKIPA which is under the control of Government of Jharkhand. But in view of the expanding activities of Judicial Academy, the need for having an exclusive building for Judicial Academy was felt. In pursuance to it, altogether 6.70 acres land was allotted in a picturesque location near the sprawling Dhurwa Dam of Ranchi. The foundation stone of the new building of Judicial Academy was laid by Hon'ble Mr. Justice K.G. Balakrishnan, the then Chief Justice of India on 17/5/2009 and was completed under continuous monitoring of Hon'ble High Court of Jharkhand and finally in the year 2015 new building of Judicial Academy Jharkhand was inaugurated by Hon'ble Mr. Justice Tirath Singh Thakur, the then Judge of Hon'ble Supreme Court of India on 10/10/2015.

Every judicial system consists of two components - a framework provided by the law and the Judges who work within the system. Effectiveness of the system usually depends on the efficiency of the men who belong to and operate the system. The judicial system, even if it is perfectly structured, may yet not be an effective justice-delivery system if the persons working as Judicial Officer and Administrative officer discharging judicial functions do not have the requisite operational skill or are not enthused to deliver robust substantial justice. Therefore, quality of justice depends more on the men who administer laws than on the laws they administer. It is an old saying that education is a technique of transmitting civilization. Education performs two major functions as it must enlighten the understanding and it must enrich the character.

The objective behind judicial training is to develop skills, knowledge, work culture, discipline and attitude among the Judicial Officers with a view to improve quality and quantity of their output. The aim and objective of Judicial Academy, Jharkhand is reflected through Gazette Notification dated 7th March, 2002, through which the Academy has been entrusted with the task to impart Induction Training to newly appointed Judicial Officers and Refresher Trainings to in-service Judicial Officers of Jharkhand State, Members of Registry of the High Court of Jharkhand, Ministerial Staff of High Court and State Judiciary along with training to the G.P., P.Ps., I.Os and other stake holders who are being nominated for said purpose. The objective of Judicial Academy is not only to impart training but also to disseminate legal and judicial knowledge and to equip and prepare Judicial

Officers for the discharge of their functions and duties in light of recent developments in all facets of law. The Academy also ensures the physical and mental well being of the trainee officers and for that regular yoga classes are also being conducted during induction training courses. On the initiative of Academy time to time yoga classes are also being conducted for Judicial Officers and staff members of Civil Courts at their place of posting for the purpose of enhancing their capacity to discharge their duties effectively and enthusiastically. The Academy takes all the positive and effective steps to bring about closer levels of interaction between the members of the Bar and the Bench and for that Academy also organizes number of Seminars, Symposiums and Workshops throughout the year.

Apart from that the Academy also conducted research work on relevant topics and for that Government of Jharkhand has sanctioned altogether four posts of Research Scholars for Constitutional Law, Civil Law, Criminal Law and Corporate & other Laws.

Judicial Academy, Jharkhand is well equipped for conducting physical as well as virtual training programmes. Even during extreme Covid Pandemic period, in course of facing challenges this Academy had shifted Judicial training from physical mode to virtual mode and did not only successfully complete one year Induction Training Programme of newly recruited Civil Judges (Jr. Division) of 2020-21, but also successfully conducted all the routine training programme scheduled as per Academic Calendar 2021-22 with regard to in-service Judicial Officers and other stakeholders.

This way Judicial Academy Jharkhand focuses on achieving the objectives of its legislation to create an atmosphere ideally conducive and fundamentally congenial for ensuring that the judicial service of Jharkhand state may reach at the level of excellence and inspire confidence of the highest order among the members of the public by adopting the best practices, techniques and strategies proven to have the highest degree of effectiveness in order to achieve its aims and also inculcate fundamental duties of a Judge which is meaningfully incorporated in Atrismhita as:-
