AIMS AND OBJECTIVES OF JUDICIAL ACADEMY, JHARKHAND

Judicial Academy, Jharkhand, came into existence on 4th January, 2002 at Ranchi, pursuant to the direction of the Hon'ble Apex Court passed in "All India Judges Association Case" reported in 2002 (4) SCC 247. Its first Patron-In-Chief was Hon'ble Mr. Justice V.K. Gupta, the first Chief Justice of Jharkhand. Initially it started in a part building of Shri Krishna Institute of Public Administration (SKIPA) at Meur's Road, Ranchi. In view of expanding activities of Academy, a need for its exclusive building was felt. Then in pursuance to it a piece of land measuring 6.70 acres was allotted in a picturesque location near the sprawling Dhurwa Dam, Ranchi for the construction of its new building. The foundation stone of the new campus was laid down by Hon'ble Mr. Justice K.G. Balakrishnan, the then Chief Justice of India on 17/5/2009, which was finally completed in the year 2015, under continuous monitoring of Hon'ble High Court of Jharkhand and finally it was inaugurated on 10th October, 2015 by Hon'ble Mr. Justice Tirath Singh Thakur, the then Judge of Hon'ble Supreme Court of India.

It's a well known fact that every judicial system consists of two components (i) a framework provided by the law and (ii) the Judges who manned the system. Effectiveness of the system usually depends on the efficiency of the men who belong to and operate the system. Any judicial system, however perfectly structured, may yet not work efficiently and effectively, if the persons discharging judicial functions do not have the requisite operational skill or are not enthused to deliver robust substantial justice. Quality of justice depends more on the men who administer laws than on the laws they being administered. Basically education is a technique of transmitting civilization, which performs two major functions of enlighten the understanding and to enrich the character.

Objectives behind establishment of academy, as reflected through Gazette Notification dated 7th March, 2002, is to develop skills, knowledge, work culture, discipline and attitude among the Judicial Officers with a view to improve quality and quantity of their output. The academy is entrusted with the task of imparting Induction Training / Orientation training to the newly appointed Judicial Officers of different cadres and also to conduct Refresher Training Programmes for in-service Judicial Officers, Ministerial Staff of High Court and District Courts along with organising training programmes for the G.P., P.Ps., I.Os. and other stake holders. Existence of academy is justified not only by its role in imparting training to all the stakeholders of justice dispensation system but also by disseminating legal knowledge in order to equip and prepare all the stakeholders for discharging of their day to day judicial functions and duties efficiently in the light of fast changing facets of law. Academy has also to ensure the physical and mental well-being of the Judicial officers and for that time to time yoga classes are also being conducted for all the Judicial Officers and staff members of Civil Courts even at their respective places of posting with a motive to enhance their capacity to discharge their duties effectively and efficiently. It also takes all the positive and effective steps to bring closer levels of interaction between the members of the Bar and the Bench and for that number of Seminars, Symposiums and Workshops are being organized throughout the year.

Judicial Academy, Jharkhand is well equipped with all infrastructural support for conducting training programmes through physical as well as virtual mode. Even during extreme Covid Pandemic period, number of successful training programmes were conducted through virtual mode. Even last Induction Training Programme of newly recruited officers of Civil Judges (Jr. Div.) of 2020-21 was successfully completed in hybrid mode. In previous academic year, academy had not only conducted training programmes for Judicial Officers and other stakeholders of Jharkhand in hybrid

mode, but also successfully hosted East Zone - I Regional Conference under the aegis of National Judicial Academy, Bhopal in which participants were the nominated hon'ble Judges of High Courts and Judicial Officers of the four states namely Jharkhand, Bihar, Orissa and Chhatisgarh. Academy has also hosted two International Training Programmes viz. (a) "Training of Trainers on Counter Terrorism (TOT-2) course" organised by National Judicial Academy, Bhopal, in collaboration with Central and East European Law Initiative (CEELI Institute), Prague and Federal Judicial Centre (FJC), Washington DC and (b) Training programme for 50 Bangladesh Judges and Judicial Officers (SE-12) under the aegis of National Judicial Academy, Bhopal. Academy had proud privillage to honour Hon'ble Mr. Justice N. V. Ramana, the then Chief Justice of India and other Hon'ble Judges of Apex Court like Hon'ble Mr. Justice Aniruddha Bose, Hon'ble Mr. Justice M. R. Shah, Hon'ble Justice Ms. B.V. Nagarathana, Hon'ble Justice Ms. Indira Banerjee, who had graced number of conferences conducted during the Academic Year 2022-23.
