





B-DIARY

The B diary is a facility to generate entire history of the case till its last date of hearing. Its entire history of the case from its first date till the last date of hearing along with Business recorded in its last date before the Court. This helps us to see the entire progress of the case in a single document with all the details.

This option is used to view and print the B Diary. When you Click B Dairy sub menu, the "B Dairy" screen is displayed. Select the Case Type from the Case Type select box. Enter the Case Number, Year, and Click Go button. The system will load View link. Click the View link, the report with the details given below are displayed:
