
CIS 4.0 INTRODUCED INTEGRATION WITH PRISONER ID LIKELY TO GET OPERATIONAL SOON

A Prisoner ID (also called Inmate ID or Prison Number) is a unique identification number assigned to a person when they are officially registered in a prison or jail system

Used for-

- **Identifying a prisoner inside the prison system**
- **Tracking court cases linked to the prisoner**
- **Managing jail records (admission, transfer, release)**
- **Recording medical history, visits, and disciplinary actions**
- **Linking biometric data and photographs**




It supports the new criminal laws by ensuring authenticity, integrity, and traceability of electronic evidence.


